IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO APPROVE the Choctaw Nation of Oklahoma (the "Nation") Leadership 401(k) Plan and make certain findings and issue certain directives related to the Leadership 401(k) Plan.

WHEREAS, the Tribal Council of the Choctaw Nation of Oklahoma (the "Council") is considering approval of an amended and restated Supplemental Retirement Income Plan (SRIP) and wishes to adopt the attached tax-qualified 401(k) retirement plan to be known as the Nation's Leadership 401(k) Plan to work in tandem with the SRIP;

WHEREAS, the Council finds, based on all relevant facts and circumstances and in a good faith exercise of its sovereign authority, that elected Council members shall be treated as employees solely for purposes of the Leadership 401(k) Plan and certain other employee benefit programs maintained by the Nation, and that such finding shall not affect the status of the Council members as elected officials for other purposes; and

WHEREAS, the Choctaw Nation Governmental Retirement Plan Committee (the "Committee") shall be established, which shall consist of at least four (4) members to be designated by the Chief with the advice and consent of the Council, for the purposes of the Leadership 401(k) Plan.

THEREFORE BE IT ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as the adoption of the Choctaw Nation of Oklahoma Leadership 401(k) Plan subject to such further changes as may be recommended by the Nation's legal counsel or outside tax counsel for tax and tribal law compliance, or as may be required to coordinate with outside service providers following the completion of a request for proposal to secure administration for the amended program; provided that such changes do not materially detract from the program features approved hereby without additional action by the Council". to be effective on January 1, 2023.

BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Bill be cited as the establishment of the Choctaw Nation Governmental Retirement Plan Committee, which shall consist of at least four (4) members to be designated by the Chief with the advice and consent of the Tribal Council, for the purposes of the Choctaw Nation of Oklahoma Leadership 401(k) Plan.

BE IT FURTHER ENACTED by the Tribal Council of the Choctaw Nation of Oklahoma that this Council Bill be cited as acknowledgement that elected Council members shall be treated as employees solely for purposes of the Leadership 401(k) Plan and certain other employee benefit programs maintained by the Nation, and that such finding shall not affect the status of the Council members as elected officials for other purposes.
