RONALD PERRY INTRODUCED THE FOLLOWING BILL

A COUNCIL BILL

TO APPROVE an amendment to the Water Tower and Ground Space Lease-Business Lease No. 4200028664 (G09-1889), between the Choctaw Nation and United States Cellular Operating Company of Greater Oklahoma, LLC.

WHEREAS in accordance with Article VII, Section 1 of the Constitution of the Choctaw Nation of Oklahoma (the "Nation"), the Chief shall perform all duties pertaining to the Office of the Chief Executive. He shall sign official papers on behalf of the Nation;

WHEREAS in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma, the Tribal Council (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition, and management of tribal property;

WHEREAS a water and ground space lease was approved in favor of United States Cellular Operating Company of Greater Oklahoma, LLC ("USCOC") on October 18, 2016 in CB-15-17 (the "Original Lease"). The Original Lease allowed for the placement of cellular common carrier mobile radio base station operations, including related telecommunications functions, on tribal land. See CB-15-17;

WHEREAS the Original Lease allowed for attachment locations on the water tower and for placement of radio station equipment shelter on land adjacent to the water tower at the Capitol Grounds in Tuskahoma, Oklahoma;

WHEREAS USCOC now proposes an amendment to the Original Lease. This amendment, entitled "First Amendment to Tower and Ground Space Lease" modifies the Original Lease by replacing Exhibit B in the Original Lease with Exhibit B-1. Exhibit B-1 updates the equipment allowed under the Original Lease.

WHEREAS all other terms of the Original Lease approved in CB-15-17 shall remain the same; and

WHEREAS the Tribal Council has determined it is in the best interest of the Nation to approve the amendment entitled "First Amendment to Tower and Ground Space" amending the Tower and Ground Space Lease-Business Lease No. 4200028664 (G09-1889).

THEREFORE BE IT ENACTED by the Tribal Council that this Bill be cited as approval to amend the Tower and Ground Space Lease approved by Tribal Council in CB-15-17 on October 18, 2016, and executed on February 21, 2017 (the "Original Lease").

BE IT FUTHER ENACTED by the Tribal Council that this bill be cited as approval of the proposed amendment of the Original Lease entitled "First Amendment To Tower And Ground Lease." This amendment shall replace Exhibit B of the Original Lease with Exhibit B-1. See Exhibit A. No other terms of the Original Lease shall be amended.

BE IT FURTHER ENACTED by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.

Purpose of Council Bill: This bill approves an amendment to the Tower and Ground Space Lease between the Choctaw Nation and United States Cellular Operating Company (USCOC). The Original Lease was approved by Tribal Council on October 18, 2016 and the lease was executed on February 21, 2017. The Original Lease allowed for the use of the water tower and adjacent land at the Capitol Grounds in Tuskahoma, Oklahoma. The Original Lease allowed the placement of cellular base station operations, including related telecommunications functions on the water tower and the locations of radio station equipment shelter in land adjacent to the water tower. The amendment replaces Exhibit B in CB-15-17 with Exhibit B-1 and allows for an equipment update. No other terms of the Original Lease will be altered.
