RONALD PERRY INTRODUCED THE FOLLOWING COUNCIL BILL

A COUNCIL BILL

TO AUTHORIZE the Chief of the Choctaw Nation of Oklahoma to donate the Wheeler Federal Building located in Durant, Oklahoma.

WHEREAS, in accordance with Article IX, Section 6 of the Constitution of the Choctaw Nation of Oklahoma, the Choctaw Tribal Council (the "Council") shall make decisions pertaining to the acquisition, leasing, disposition and management of real property;

WHEREAS, in accordance with Article VII, Section 1, of the Constitution of the Choctaw Nation of Oklahoma, the Chief shall perform all duties appertaining to the office of chief executive. He shall sign official papers on behalf of the Nation;

WHEREAS, the Wheeler Federal Building (the "Federal Building") was donated to the Choctaw Nation of Oklahoma (the "Nation") on September 15, 2016;

WHEREAS, the Federal Building has remained unoccupied and unused by the Nation;

WHEREAS, the Nation now wishes to donate the Federal Building to the Board of County Commissioners for Bryan County, State of Oklahoma (Bryan County); and

WHEREAS, the Nation shall convey the Federal Building to the Bryan County under the condition that the Federal Building is accepted as it is with no liability to the Nation;

THEREFORE BE IT ENACTED, that the Tribal Council of the Choctaw Nation of Oklahoma that the Bill be cited as authorization of the Chief of the Choctaw Nation of Oklahoma, or his designee, to donate the Wheeler Federal Building, located at 224 W. Evergreen Street, Durant, Oklahoma, by conveying to the Board of County Commissioners for Bryan County, State of Oklahoma.

BE IT FURTHER ENACTED, by the Tribal Council of the Choctaw Nation of Oklahoma, that this Bill be cited as approval that the Wheeler Federal Building shall be conveyed on the condition that acceptance of the property and structure is accepted as -is and Bryan County assumes all risks associated with this conveyance and the Nation is divested of all liability and responsibility.

CERTIFICATION

Eight (8) members must be present to constitute a quorum.
